What is Virginia Housing's RHS program?	Virginia Housing's RHS Bond program is a Rural Housing Service (RHS) first mortgage guaranteed by RHS and is offered to first-time homebuyers (unless purchasing in a targeted area). The loan is financed using tax-exempt bond proceeds. The interest rate for the RHS Bond program may vary compared to the RHS program. Requirements of this bond program are listed below.		
Loan Term	30 year fixed rate only.		
Maximum Lender Compensation	2.50% including SRP plus common and customary ancillary fees.		
Loan-to-Value (LTV)	Maximum 100% LTV based on the appraised value (+ financed guarantee fee – Follow RHS LTV requirements). No minimum LTV. Follow RHS requirements for maximum CLTV. <u>Exhibit LL</u> required if there is subordinate financing (except FHLB).		
Mortgage Insurance	Guarantee Fee per RHS requirements.		
MCC Eligible	No.		
SPARC Eligible	Yes in accordance with SPARC guidelines.		
Plus Second Mortgage Eligible	No.		
DPA Grant Eligible	No.		
CCA Grant Eligible	Yes in accordance with CCA Grant guidelines.		
First-time Homebuyer	 Required unless purchasing in a targeted area (applies to all borrowers). Borrowers are considered a first-time homebuyer if they have not owned and occupied a primary residence in the last 3 years. Acceptable documentation to evidence first-time homebuyer: The fully executed Programs Disclosure and Borrower Affidavit (Exhibit E) signed by all borrowers; A completed Uniform Residential Loan Application (URLA); and The credit report. Note: If unable to confirm from the Exhibit E, the URLA, or the credit report all borrowers are a first-time homebuyer, additional documentation may be required, such as: Three years' federal tax returns / tax transcripts Rent verification(s) Other reports such as a Lender Data Integrity Report (Examples: Drive Report, FraudGuard, Loansafe)

Income Limits	 Continued <u>Notes</u>: See <u>Origination Guide</u> for more information on how to calculate household income, what income types must be included, and what may be excluded (Note: RHS has different income limits and may have different household income calculation requirements). See below for details on where income must be stated on the Programs Disclosure and Borrower Affidavit. Higher income limits may apply if the property is located in a targeted area, however these higher income limits do not apply when the loan is originated with a CCA Grant. 	
Sales Price / Acquisition Cost Limits	 Refer to <u>Virginia Housing Sales Price / Loan Limits</u>. The limit is the highest of the gross loan amount(s), sales price, and acquisition cost. See <u>Origination Guide</u> for more information on how to determine acquisition cost. <u>Virginia Housing Sales Price / Loan Limits</u> apply even when the RHS maximum loan amount limits are higher. The gross loan amount (including financed closing costs and guarantee fee) cannot exceed the <u>Virginia Housing Sales Price / Loan Limits</u>. Higher sales price limits may apply if the property is located in a targeted area. 	
Maximum Loan Amount	 Follow RHS maximum loan amount requirements except: <u>Virginia Housing Sales Price / Loan Limits</u> apply even when the RHS maximum loan amount limits are higher. 	
Eligible Purpose	Primary residence purchase (no refinances).	
Residency	Must meet RHS residency requirements.	
Programs Disclosure and Borrower Affidavit (<u>Exhibit E</u>)	Required. Income from all household members must be included on page 4.	
Seller Affidavit (<u>Exhibit F</u>)	Required.	
Originating Lender's Loan Submission Cover Letter (<u>Exhibit O</u>)	Required.	
Recapture	Loan is subject to recapture.	
Homebuyer Education	Required for all first-time homebuyers. Complete Virginia Housing course, <u>HUD Approved Counseling Agency</u> course, Fannie Mae Framework, or Freddie Mac CreditSmart course prior to approval. Fannie Mae's Homeview course is not acceptable. Homebuyer Education Certificate is valid for 2 years.	
Tax Transcripts	Virginia Housing does not require tax transcripts for this program, however RHS may have its own different tax transcript requirements. Lender follow RHS requirements.	
Business Use of Home	 No more than 15% of the financed dwelling may be used primarily in a trade or business. The borrowers must fully execute the <u>Business Use of Home Certification</u> if the borrower has disclosed that a part of the current residence is being used primarily for a trade or business or if there is any other evidence in the file, such as: The employment business address is the same as the borrower's current residence address and/or the borrower has marked yes for mixed-use property on the URLA, or Federal tax returns are provided and show the "business in home" deduction was taken (Typically this shows on Schedule C, line 30). The <u>Business Use of Home Certification</u> certifies that not more than 15% of the total living area of the subject property will be used primarily in a trade or business. If greater than 15% will be used in the subject dwelling then the borrower is not eligible. 	
Maximum Net Worth	Cannot exceed 50% of sales price (See <u>Origination Guide</u> for more information).	



Automated Underwriting System (AUS) / Manual Underwrites	 Guaranteed Underwriter System (GUS) Accept Eligible. GUS decision of Ineligible is not acceptable. GUS decision of Refer may be manually underwritten as long as the loan meets the more restrictive of Virginia Housing requirements and RHS manual underwrite requirements. Manual Underwrite is acceptable, including borrowers with no credit score. Must meet RHS Non-Traditional credit requirements and all other RHS manual underwrite requirements. 		
Minimum Credit Score	620 (no exceptions) for all borrowers.If a borrower does not have sufficient credit to obtain a credit score then the loan must be manually underwritten as indicated above.		
Maximum DTI	50% (no exceptions) with AUS Approval. Manually underwritten loans must meet more restrictive ratio requirements of Virginia Housing and RHS.		
Non-Occupant Co-Borrowers	Not allowed.		
Ineligible Qualifying Income	Boarder Income Accessory Unit Income		
Foreclosures / Deed in Lieu / Short Sales	Follow RHS waiting period requirements.		
Collections / Judgments	Follow RHS requirements.		
Minimum Borrower Contribution	Follow RHS requirements.		
Reserves / Acceptable Funds to Close	Follow RHS requirements for reserves and funds to close (including a gift). <u>Exhibit LL</u> required if there is subordinate financing (except FHLB).		
Interested Party Contributions	Follow RHS requirements.		
Property	 Single family (1 unit) detached, attached, RHS approved condominium (lender to certify condo approval and provide documentation). Manufactured Homes must meet RHS and see <u>Origination Guide</u> for additional requirements. Property must be located in Virginia and must be RHS eligible. Acreage: The maximum lot size is 2 acres. Exceptions are considered > 2 up to 5 acres. The Lender's underwriter must review and render a decision on the acreage exception. See the <u>Origination Guide</u> for additional requirements and criteria. 		
UCDP / Collateral Underwriter	Not required.		
Unfinished Area	The cost to complete unfinished areas that are suitable to finish in the property must be included in the acquisition cost on the <u>Exhibit E</u> and <u>Exhibit F</u> (Examples: Unfinished basement, lower level of a tri-level, etc.). See the <u>Origination Guide</u> for more information.		
Post-Closing Repairs	Escrows for post-closing repairs considered case by case as an exception. The Originating Lender's underwriter must review and render a decision on the exception. See the <u>Origination Guide</u> for additional requirements and criteria. No structural or major mechanical repairs allowed.		
General Guidelines	Unless otherwise noted follow RHS requirements (with program overlays).

Lock-In	Loans locked on Virginia Housing's LOS – <u>Mortgage Cadence</u> – Select RH30F_BOND. Different pricing available for this product than Virginia Housing's RHS product. Follow steps outlined in the <u>Mortgage Cadence User Guide</u> for registering and locking loans.	
LLPAs	No additional Loan Level Price Adjustments (LLPAs).	
Origination	Loan originated in accordance with program guidelines and RHS guidelines.	
Lender Delegated Underwriting Availability	Delegated underwriting is available to all approved Virginia Housing delegated lenders. Lender's underwriter assumes full responsibility for compliance with RHS underwriting requirements. Lenders can contact their Business Development Officer for questions / concerns about delegation.	
Underwriting	Loans underwritten in accordance with program guidelines and RHS guidelines. Lender's underwriter assumes full responsibility for compliance with RHS underwriting requirements. Non-Delegated lenders must submit to Virginia Housing prior to closing – must use the	
	Underwriting Submission Checklist. It is preferred that Non-Delegated lenders include the RD Conditional Commitment 3555-18 when submitting to Virginia Housing underwriting for pre-closing review.	
	Follow steps outlined in the <u>Mortgage Cadence User Guide</u> for submitting a Non- Delegated loan to Virginia Housing Underwriting or submitting for Delegated Approval.	
Special Documentation	The RHS Bond program requires a RHS (and Conventional) Tax-Exempt Financing Rider to be executed at closing.	
Closing	Loans closed in accordance with standard RHS guidelines. Loan must be closed in the name of the lender, registered in MERS with MERS compliant documents.	
UCD	Not required.	
Documents	Final AUS, URLA, and Transmittal must match (standard RHS tolerances allowed).	
Funding	Originating lender will fund the first mortgage at closing.	
Delivery	Loans submitted to Virginia Housing within 10 calendar days of closing. Follow steps outlined in the <u>Mortgage Cadence User Guide</u> for submitting a closed loan package. Documents must be uploaded using the <u>Loan Stacking Form</u> .	
Pre-Purchase Review	Loans reviewed by Virginia Housing prior to purchase. If errors noted, Virginia Housing will contact lender.	
Post-Closing	Standard post-closing documents must be submitted to Virginia Housing.
